


Eligible Schools <i>Note: Community Colleges and For-Profit schools are not eligible for this loan.</i>	<ul style="list-style-type: none"> Online application requires borrower to select from approved school list the school from which the borrower has graduated and requires borrower to enter the graduation date. The approved school list is provided by CUSC and consists of eligible schools which are four year public or private institutions eligible for participation in Title IV programs of the Higher Education Act, and approved by credit union and insurer. <ul style="list-style-type: none"> The school must be a not-for-profit school accredited by a recognized accrediting body The school's central administrative offices must be located in the United States School must be physically located in the United States For a complete list of participating schools (over 2,000), visit https://www.studentchoice.org/resources/approved-schools/
