

2025-2026 SCHOLARSHIP PROGRAM \$15,500 IN SCHOLARSHIPS AWARDED

COPFCU is proud to provide scholarships to members seeking to better their lives through continuing education. For the 2025-2026 school year, COPFCU will be awarding **five scholarships totaling \$15,500.** All scholarships are one-time awards with funds disbursed in August.

- Irvin Specht Memorial Scholarship \$4,000
- Emily Argo Memorial Scholarship \$4,000
- COPFCU Bright Futures Scholarship \$4,000
- First Runner-Up Scholarship \$2,000
- Second Runner-Up Scholarship \$1,500

To qualify you must:

Be a COPFCU member in good standing (primary membership under your name and social security number).

Be at least a senior in high school or current student who will be enrolled full-time during August 2025 - June 2026 in one of the following:

- Community college / university / graduate school
- Trade / vocational school

Submit proof of acceptance / enrollment in classes to be taken from August 2025 - June 2026.

Submit proof of cumulative GPA of 2.5 or above for the most recent school term (whether high school, college, or vocational/trade school).

Submit the attached application and essay responses, including all items noted above, by 5pm on **February 14, 2025**.

Recipients will be determined by the COPFCU Scholarship Committee. Notification will be made by April 1, 2025.
